

Terms and Conditions:

This website is the official website of the Benji Hillman Foundation, registered foundation number: (580466332). hereinafter: "the foundation"

The website makes it possible to contribute to the financing of the foundation's activities and to expand the foundation's activities and facilities. Any use of this website, including making donations, constitutes the consent of the user to act in accordance with these terms.

Everything stated in these terms in masculine language also applies to females. What is said in the singular language also applies to plural, and vice versa.

The website and its contents were created by the foundation, and their purpose is to raise awareness and give information regarding the foundation's activities among the soldiers, donors and volunteers, as well as to share information about the foundation's activities and update on the foundation's activities.

The Benji Hillman Foundation takes responsibility for the information on the payment page.

The Foundation allows to donate money for the benefit of the foundation's needs, and other needs through the website, based on decisions made by the foundation's board of directors.

The Foundation reserves the right to update, change, add and detract from the terms, without any prior or late notice, in its sole discretion. Each notice will be published at the discretion of the "Foundation". Including the new conditions as they may be.

The use of this website for the purpose of making a donation by credit card or any other means, is only permitted to donors who are over 18 years old. Anyone making a donation is hereby declaring that they meet the legal requirements stated by the law. When making a donation using a credit card, the card will be checked with the credit card company and the payer/donor will receive an immediate answer regarding the status of the transaction, and whether it was accepted or rejected.

The payment page on the site is secured by a strict DSS-PCI protocol.

The foundation undertakes not to infringe on the privacy of those making payments through the website and to act in accordance with the full provisions of the Privacy Protection Law of 1981.



Providing an email address on the website constitutes consent to receive mailings from the foundation.

Anyone making payments is entitled to reach out to the foundation for a change in the billing details and cancellation of the transaction within 14 days from the date the payment notice was given by telephone, or the payment was performed online. The foundation will make the required change in accordance with the policy in place at the time by the credit company. If the credit company charges the foundation a fee for the transaction, the operator of the transaction will be charged a fee as stated. Any cancellation will be made in accordance with the Consumer Protection Law of 1981.

It is prohibited to give false details and doing so is a criminal offense. A person who commits this offense is subject to legal, criminal and civil proceedings.

No information may be copied, reproduced, transmitted, distributed, displayed, relied upon and provided from the site without the prior consent of the foundation.

Only the existing terms and laws in the State of Israel will apply to this foundation's website. The interpretation of these By-Laws, their enforcement, or any action and / or conflict arising therefrom, shall be made in accordance with the laws of the State of Israel. Any dispute or question in the context of these By-Laws will be decided by the certified court in the Tel Aviv-Yafo District only.

The site operators can change the terms of use anytime they see fit, as needed, and the user of the site must make sure that he knows the latest version of the terms of use. The binding wording of the terms of use is the one that will be valid when using the site.
